

What is Home Health Care?

Home Health Care provides an alternative to hospital care or other types of institutional health care by offering skilled care and treatment in the comfort, security and privacy of your own home.

The **Center for Health Care Services Home Health Agency** provides quality, professional, home health care to individuals with medical and mental health needs in the privacy of their own homes. There are many services and different types of health care available in the home setting. CHCS Licensed and Certified Home Health Agency offers a wide range of services provided by nurses and other health care professionals which foster recovery, rehabilitation, recuperation and health education.

The **Center for Health Care Services Home Health Agency** works closely with family members, hospitals, physicians, and other members of the medical team to develop the home care plan that will best meet your needs.



Who is qualified for Home Health Care Services?

Skilled home health services are available to people of all ages. Typically they include individuals who are discharged from the hospital or nursing homes but still require additional care, or individuals who are referred by their physician for short or long term health care needs.

What is the referral process?

Anyone can refer you for our services, your doctor, family, friends, hospital discharge personnel, nursing homes, rehabilitation unit. You can even refer yourself to the **Center for Health Care Services Home Health Agency**.

Accepted Insurance

Home health care is a Medicare Part A benefit which requires no co-pay or deductible. Other payment sources may include:

- Medicaid
- Private Insurance
- Workers Compensation
- Superior Health Plan

Explanation of Home Health Care Services

Skilled Home Health Care requires a physician's order to access and implement the services of an RN or LVN, PT, OT ST, LCSW, and/or HH Aide.

The Agency's telephone is answered 24 hours a day 7 days a week with an RN available.

Services provided include:

Skilled Nursing Disease process management and in-depth education for the patient /caregiver such as:

- Medication teaching, medication management
- Blood pressure monitoring, diabetic blood glucose monitoring, insulin injections
- Diet / Nutrition
- Cardiac disease management
- Home safety and fall prevention teaching
- Respiratory disease management / teaching and treatments
- Urinary catheter and ostomy management
- Wound assessment and care
- Home Health Aide for personal care and hygiene

Therapy Services:

Physical Therapy for implementation of therapy gait training, balance, home exercise for increase in endurance and strength

Occupational Therapy for ADL (dressing, bathing, feeding), energy conservation/ breathing, upper body strength

Speech Therapy for multiple speech irregularities and swallowing difficulties

Licensed Clinical Social Work assistance for patient dynamics as related to your health care needs.
